For Zoho Transmail Product - New UI, We implemented the EmberJS and we studied and convey the things to other developers. To support the Client MVC framework, we implemented REST API in Server using the Jersey framework. This application will help to send the mail without any delay. And track it's sent & bounce mail and Open & Click count of the mail and the link with help of the webhooks & Kafka services.
